9 **AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF**
10 **LITTLETON, COLORADO, AS THE GOVERNING BODY OF**
11 **THE CITY OF LITTLETON STORMWATER AND FLOOD**
12 **MANAGEMENT UTILITY ENTERPRISE, AMENDING THE 2018**
13 **BUDGET**

16 **WHEREAS**, the city council established the City of Littleton Stormwater and
17 Flood Management Utility Enterprise (the "Enterprise") by Ordinance No. 33, Series of 2013;
18 and

19 **WHEREAS**, the city council, as the governing board of the Enterprise, has the
20 authority under said ordinance to establish the budget for the Enterprise; and

22 **WHEREAS**, Ordinance No. 27, Series of 2017 established the budgeted
23 expenditures for the City of Littleton Stormwater and Flood Management Utility Enterprise; and

25 **WHEREAS**, the necessity of receiving and expending additional monies from the
26 Enterprise could not have been reasonably anticipated during the time of adoption of this budget
27 and appropriation of funds in accordance therewith;

30 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF**
31 **THE CITY OF LITTLETON, COLORADO, THAT:**

33 **Section 1:** The budgeted expenditures for the City of Littleton Stormwater and
34 Flood Management Utility Enterprise for the period January 1, 2018 to December 31, 2018 are
35 hereby amended by the following addition:

41 **Section 2:** The total budgeted expenditures for the City of Littleton Stormwater
42 and Flood Management Utility Enterprise for the period January 1, 2018 to December 31, 2018
43 shall be amended to \$916,045.

45 **Section 3:** Severability. If any part, section, subsection, sentence, clause or
46 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the
47 validity of the remaining sections of this ordinance. The City Council hereby declares that it
48 would have passed this ordinance, including each part, section, subsection, sentence, clause or
49 phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences,

1 clauses or phrases may be declared invalid.

3 **Section 4:** Repealer. All ordinances or resolutions, or parts thereof, in
4 conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the
5 repealer clauses of such ordinance nor revive any ordinance thereby.

8 INTRODUCED AS A BILL at a regularly scheduled meeting of the City Council
9 of the City of Littleton on the 6th day of March, 2018, passed on first reading by a vote of 7 FOR
10 and 0 AGAINST; and ordered published by posting at Littleton Center, Bemis Library, the
11 Municipal Courthouse and on the City of Littleton Website.

12 PUBLIC HEARING on the Ordinance to take place on the 20th day of March,
13 2018, in the Council Chamber, Littleton Center, 2255 West Berry Avenue, Littleton, Colorado,
14 at the hour of 6:30 p.m., or as soon thereafter as it may be heard.
