12 13 14 15	WHEREAS, Littleton Public Schools desires to replace outdated playground equipment at Field Elementary School; and
16 17 18	WHEREAS, the city has been cooperating with Littleton Public Schools to address playground improvements at their facilities attended by students residing within the City of Littleton; and
20 21 22	WHEREAS, the current enrollment in Field Elementary School consists of 288 homes within the city limits of Littleton out of 308 total families enrolled; and
23 24 25 26	WHEREAS, the proposed playground improvements at Field Elementary School will address safety, accessibility, and improve the general appeal of the play area and include new play equipment, shade structures, student gardening area, ball courts, music and sand play areas, and seating areas, among other improvements; and
27 28 29 30	WHEREAS, the city's matching funds portion of \$50,000 will be presented to the city council during the second quarter of 2018 as a supplemental budget appropriation to secure the funds; and
31 32 33 34	WHEREAS, the city will act as the submitting entity for the application and should the grant be funded, will also act as the pass-through administrator of the grant; and
35 36 37	WHEREAS, should the project be funded, the city council authorizes the city manager or his designee to sign a grant agreement and grant reports with Arapahoe County; and
38 39 40	WHEREAS, should the project be funded, the city and Littleton Public Schools will enter into a public use agreement for the Field Elementary School playground that will ensure public access to the playground outside of school use.
41 42 43	NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LITTLETON, COLORADO, THAT:
44 45 46	The City of Littleton supports and agrees to submit on behalf of Littleton Public Schools a grant application for 2018 Arapahoe County Open Space funds for playground
