20	WHEREAS, South Metro Fire and Rescue District (hereinafter, "South Metro		
21	Fire Rescue") provides fire and emergency services in the political subdivisions adjacent to City;

24	WHEREAS, the parties that Littleton Fire Rescue provides Fire and Emergency		
25	Services to (Highlands Ranch Metro District and Littleton Fire Protection District) (hereinafter		
26	"the Districts") have entered into agreements pertaining to the inclusion of both Districts into		
27	South Metro Fire Rescue, subject to the approval of the voters in each respective district; and

29	WHEREAS, the Districts have agreed to terminate their agreements with the City		
30	and will participate in a fire authority organized by South Metro Fire Rescue effective January 1,		
31	2019; and		
32	WHEREAS, the City has entered into negotiations with South Metro Fire Rescue		
33	and has reached agreement on a proposed Pre-Inclusion Agreement; and

35	WHEREAS , the city council finds it to be in the best interest of the health, safety		
36	and welfare of the citizens to enter into the Pre-Inclusion Agreement with South Metro Fire		
37	Rescue for Fire and Emergency Services; and

39	NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF		
40	THE CITY OF LITTLETON, COLORADO, THAT:
