## 1 CITY OF LITTLETON, COLORADO 2 3 Resolution No. 23 4 5 **Series**, 2018 6 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF 7 LITTLETON, COLORADO, APPROVING AN INTERGOVERNMENTAL 8 9 AGREEMENT FOR A COLLABORATIVE TRANSPORTATION FORUM 10 WITH CITY OF AURORA, TOWN OF BENNETT, TOWN OF BOWMAR, 11 CITY OF CENTENNIAL, CITY OF CHERRY HILLS VILLAGE, TOWN OF COLUMBINE VALLEY, TOWN OF DEER TRAIL, CITY OF 12 ENGLEWOOD, TOWN OF FOXFIELD, CITY OF GLENDALE, CITY OF 13 14 GREENWOOD VILLAGE, CITY OF LITTLETON, CITY OF SHERIDAN, 15 AND ARAPAHOE COUNTY 16 17 WHEREAS, the council may, by resolution, enter into contracts with other 18 governmental bodies to furnish or receive government services, to make or pay charges for such 19 services, or enter into cooperative or other joint activities with other governmental bodies; and 20 21 WHEREAS, the city council desires to participate in the intergovernmental 22 agreement with the other listed municipal Agencies in Arapahoe County through its Transportation Improvement Program (TIP) to become eligible for Denver Regional Council of 23 24 Government (DRCOG) applications for federal funding for transportation projects beneficial to 25 citizens of the participating jurisdictions; and 26 27 WHEREAS, the coordinated efforts of all the Agencies are necessary to implement the Sub-Regional Funding allocation to meet the needs of Arapahoe County residents 28 29 currently and in the future; and 30 31 WHEREAS, the DRCOG Board of Directors has established that Regional 32 Project applications shall only be accepted from the Colorado Department of Transportation 33 (CDOT), Regional Transportation District (RTD), and the Sub-Regions within DRCOG's 34 boundary; and 35 36 WHEREAS, the DRCOG Board has authorized local governments within 37 Arapahoe County Sub-Region to propose jointly to the DRCOG Board of Directors allocation of federal transportation funding for transportation improvements within Arapahoe County's 38 39 incorporated and unincorporated areas; and 40 41 WHEREAS, the Agencies, as signatories hereto, desire to establish a forum of local Agency jurisdictions within the Arapahoe County Sub-Region (Forum) in order to 42 43 coordinate transportation planning and funding requests to the TIP among such participating

Agencies.
