- 2. The applicant will, with staff oversight, provide compliance with agreed upon neighborhood meeting conditions as discussed during the planning commission hearing;
- 3. No recreational vehicles will be allowed to be parked on the site;
- 4. (The following items will be included as conditions of approval as laid out by Carol Kuhn during the Planning Commission Meeting):
- Lighting shall be reduced to security levels from 9pm-6am;
- Fences shall be repaired and shall be in conformance with Littleton Code Section 10-4-3;
- Security gates shall be installed, subject to review and approval by Community Development, Public Works, and Littleton Fire Rescue;
- Open space and landscaping shall comply with the City's zoning regulations and shall be reviewed and approved with the site development plan;
- No outdoor vehicle repair shall be conducted on Lot 7, Block 1;
- No parking of large profile vehicles shall be permitted on the north-west to south-east boundary facing residential houses;

Motion by Commissioner Swartzbacker, seconded by Commissioner Coronato, to amend the main motion and include condition of

- No off-loading of cars on E. Phillips Avenue or in the parking lot, carries unanimously.
