The undersigned (who, if a natural person, is eighteen years of age or older), acting as incorporator, hereby adopts the following articles of incorporation pursuant to the laws of Colorado:

#### ARTICLE I NAME

The name of the corporation is Suncor Energy Sales Inc.

### ARTICLE II PURPOSE AND DURATION

The nature, objects and purposes of the business to be transacted shall be to engage in all lawful business for which corporations may be incorporated pursuant to the laws of Colorado. The corporation shall have perpetual existence.

# ARTICLE III AUTHORIZED CAPITAL; TERMS

- Section 3.1 <u>Authorized Capital</u>. The aggregate number of shares that the corporation shall have authority to issue is 10,000 shares of common stock, par value \$0.01 per share, and 5,000 shares of preferred stock, par value \$0.01 per share.
- Section 3.2 <u>Common Stock</u>. - Section 3.3 <u>Preferred Stock</u>. The board of directors of the corporation may, by resolution and within the limits set forth in the Colorado Business Corporation Act, determine the preferences, limitations and relative rights of the shares of preferred stock or may divide the

shares of preferred stock into one or more series and determine the designation, preferences, limitations and relative rights thereof. Before issuing any shares of preferred stock or any shares of any series of preferred stock created by the board of directors as provided above, an amendment to these Articles of Incorporation shall be made and filed, without the necessity of shareholder action, in accordance with the then applicable requirements of the laws of the State of Colorado.

#### ARTICLE IV VOTING OF SHARES

Each shareholder of record entitled to vote in the election of directors shall have one vote for each share of stock standing the shareholder's name on the books of the corporation, except that in the election of directors each shareholder shall have the right to vote all such shareholder's votes for as many persons as there are directors to be elected and for whose election such shareholder has the right to vote. Cumulative voting shall not be allowed in the election of directors or for any other purpose.

### ARTICLE V NO PREEMPTIVE RIGHTS

No shareholder of the corporation shall have any preemptive or other right to subscribe for or otherwise acquire any additional unissued shares of stock, or other securities of any class, or rights, warrants or options to purchase stock or scrip, or securities of any kind convertible into stock or carrying stock purchase warrants or privileges.

#### ARTICLE VI BOARD OF DIRECTORS

The corporate powers shall be exercised by or under the authority of, and the business and affairs of the corporation shall be managed under the direction of, a board of directors. The number of directors shall be fixed and may be altered from time to time as provided in the bylaws of the corporation. The initial number of directors shall consist of one person.
