**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
LITTLETON, COLORADO, APPROVING A MEMORANDUM OF
UNDERSTANDING FOR A COLLABORATIVE TRANSPORTATION
FORUM WITH CITY OF AURORA, CITY OF CASTLE PINES, CITY OF
LITTLETON, CITY OF LONE TREE, TOWN OF CASTLE ROCK,
TOWN OF LARKSPUR, TOWN OF PARKER, AND DOUGLAS COUNTY**

WHEREAS, the council may, by resolution, enter into contracts with other governmental bodies to furnish or receive government services, to make or pay charges for such services, or enter into cooperative or other joint activities with other governmental bodies; and

WHEREAS, the city council desires to participate in the intergovernmental agreement with the other listed municipal Agencies in Douglas County through its Transportation Improvement Program (TIP) to become eligible for Denver Regional Council of Government (DRCOG) applications for federal funding for transportation projects beneficial to citizens of the participating jurisdictions; and

WHEREAS, the coordinated efforts of all the Agencies are necessary to implement the Sub-Regional Funding allocation to meet the needs of Douglas County residents currently and in the future; and

WHEREAS, the DRCOG Board of Directors has established that Regional Project applications shall only be accepted from the Colorado Department of Transportation (CDOT), Regional Transportation District (RTD), and the Sub-Regions within DRCOG's boundary; and

WHEREAS, the DRCOG Board has authorized local governments within Douglas County Sub-Region to propose jointly to the DRCOG Board of Directors allocation of federal transportation funding for transportation improvements within Douglas County's incorporated and unincorporated areas; and

WHEREAS, the Agencies, as signatories hereto, desire to establish a forum of local Agency jurisdictions within the Douglas County Sub-Region (Forum) in order to coordinate transportation planning and funding requests to the TIP among such participating Agencies.
