22	Transportation Improvement Program (TIP) to become eligible for Denver Regional Council of

26	WHEREAS, the coordinated efforts of all the Agencies are necessary to
27	implement the Sub-Regional Funding allocation to meet the needs of Jefferson County residents
28	currently and in the future; and

31	Project applications shall only be accepted from the Colorado Department of Transportation
32	(CDOT), Regional Transportation District (RTD), and the Sub-Regions within DRCOG's

35	WHEREAS, the DRCOG Board has authorized local governments within
36	Jefferson County Sub-Region to propose jointly to the DRCOG Board of Directors allocation of
37	federal transportation funding for transportation improvements within Jefferson County's
38	incorporated and unincorporated areas; and

40	WHEREAS, the Agencies, as signatories hereto, desire to establish a forum of
41	local Agency jurisdictions within the Jefferson County Sub-Region (Forum) in order to
42	coordinate transportation planning and funding requests to the TIP among such participating
43	Agencies.
