Precedential motion made by Commissioner Swartzbacker, seconded by Commissioner Miller, to continue the resolution to the October 8 planning commission meeting in order to gather more information. -- Motion carries 5-2, with Commissioners Reynolds and Rudnicki against, and cancels the main motion.
