Miscellaneous Information

The Licensing Authority Guidelines exist to offer direction to the Littleton Licensing Authority in matters of process for all aspects of liquor and medical marijuana licensing.

The Licensing Authority Guidelines give authority to the City Attorney to determine if/when a renewal application should be brought before the Authority for consideration of approval/denial. Our current practice is to schedule a pre-renewal hearing to determine if a renewal hearing¹ is necessary. This practice is in direct conflict with the authority given the City Attorney by the Guidelines. Staff has determined that this, as well as potential other practices, must be reviewed and amended to mirror what our actual practices are and what, if any, dictated statutory requirements are met.

Once staff has had an opportunity to review this document, amendments will be made and the Authority will be given an opportunity to review and submit questions regarding changes to process.

¹ We may have a renewal hearing in September following this updated process (i.e. without having previously presented it to the Authority as a pre-renewal hearing). The renewal hearing will be conducted like any other public hearing, allowing the applicant/licensee, as well as other interested parties, to offer testimony to why the license should, or should not, be renewed.
