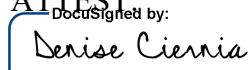

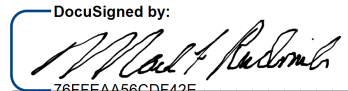
Section 1. The planning commission finds that the official zoning map conforms to the intent of Title 10, Section 10-1-6 of the city code.

Section 2. The planning commission does hereby forward a recommendation of approval to the city council for adoption of the official zoning map.

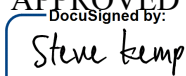

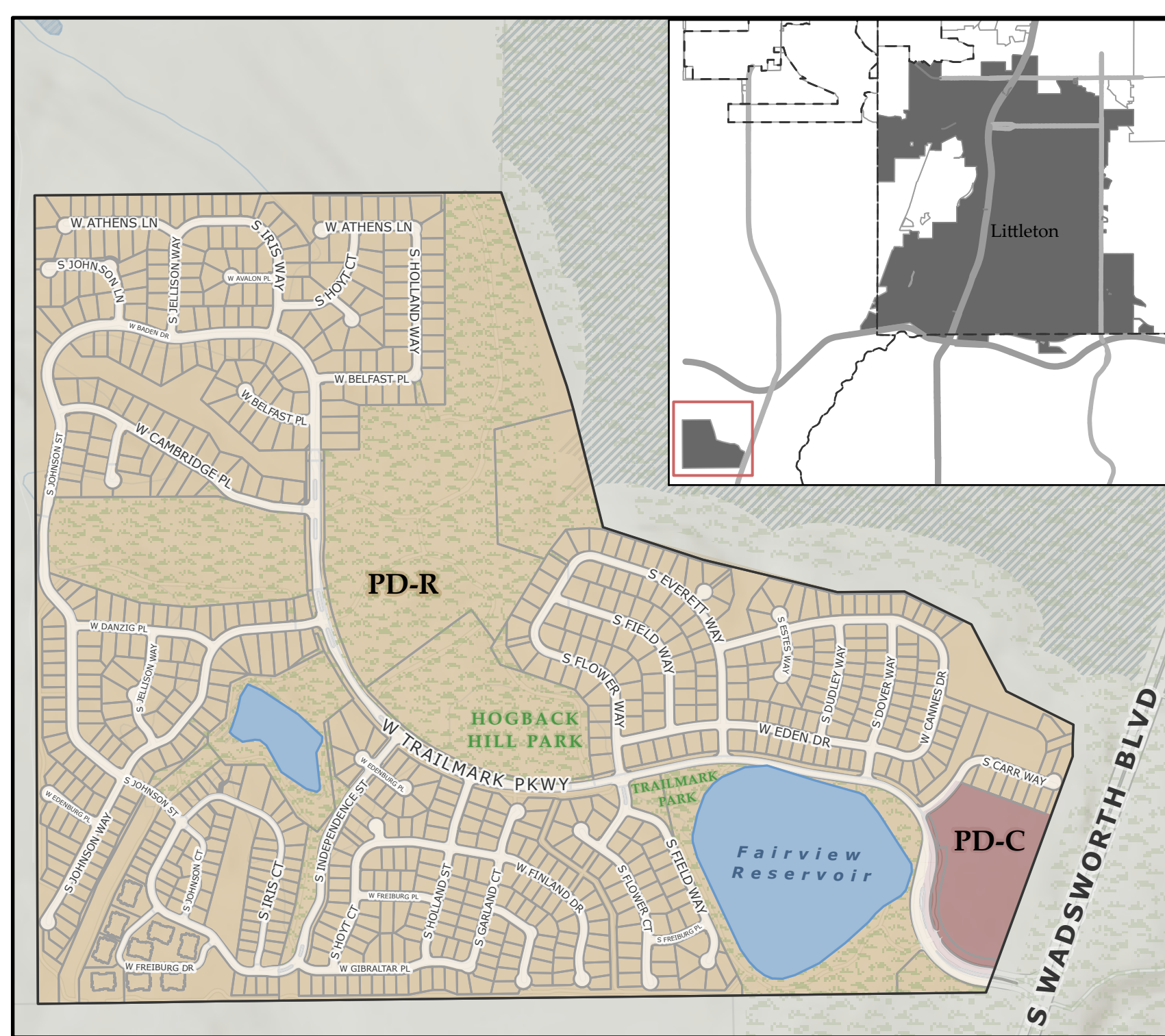
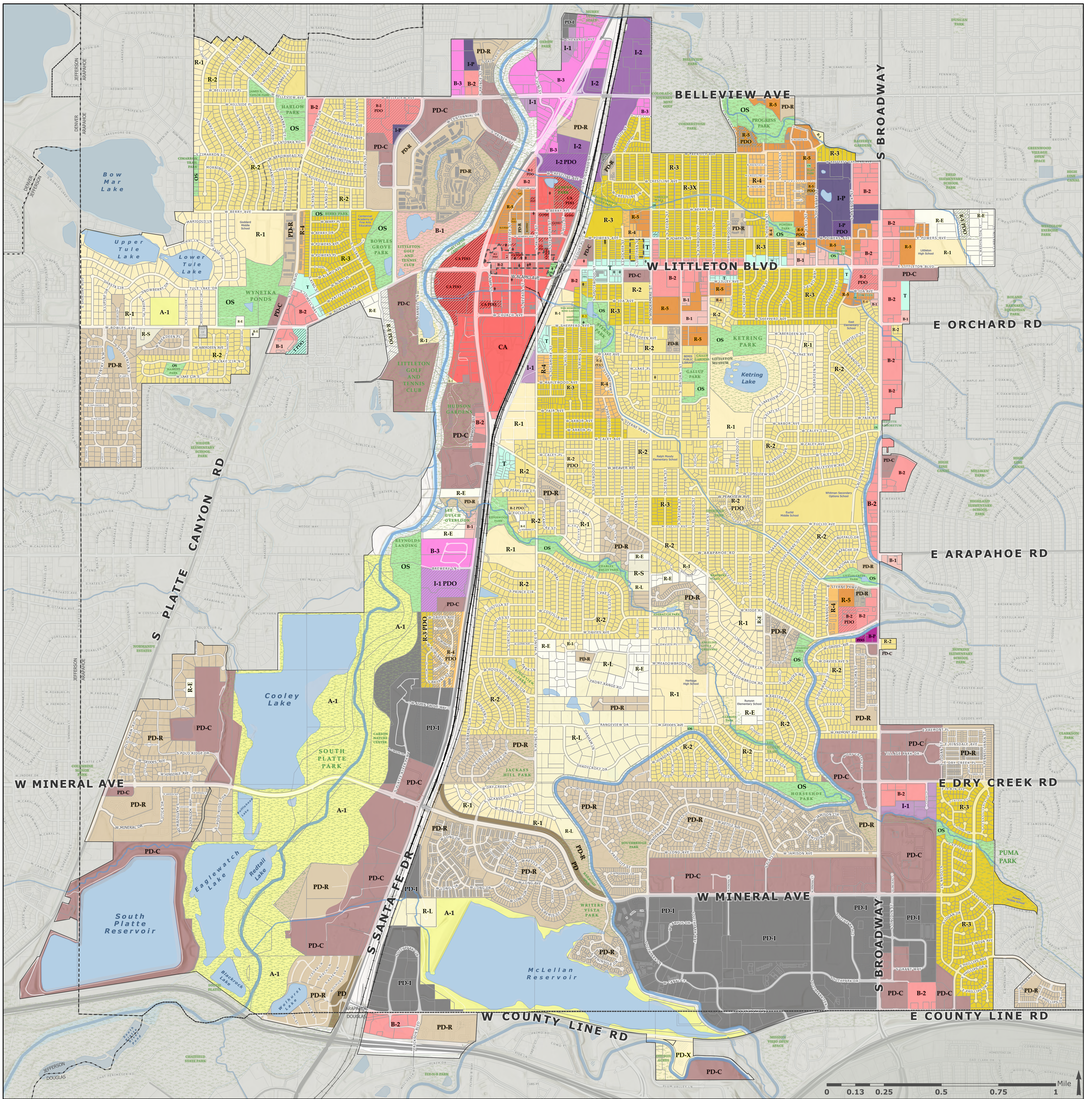
