A motion was made by Board Member Kastner, seconded by Board Member Fischer, to deny HPB Resolution 08-2018, concerning the Certificate of Historic Appropriateness for 2679 W Main Street, The Littleton Mixed Use Building.

The foregoing denial is based on the findings that the proposed work:

- 1) Does not detrimentally alter destroy or adversely affect the architectural or landscape featrures that contribute to the original historic designation;
- 2) is in conformance with Littleton design standards and guidelines which do not address ATMs;
- 3) Number/Criterion 3 does not apply;
- 4) Is not visually compatible with development on adjacent properties for the following reasons:
- a. Previous HPB decision did not allow an ATM on the front facade of Main Street:
 - b. There is concern over making the front windows on Main Street opaque;
 - c. Concern over the lighting on the ATM.

The vote on the motion is 6-1 with Board Member Hill against, and the motion to deny carries.
