A motion was made by Commissioner Stahlman, seconded by Commissioner Bolt, to approve PC Resolution 06-2019 concerning the proposed rezoning and GPDP for Our Lady of Mt Carmel Catholic Church, which forwards a favorable recommendation to city council with the condition that in the event the church ceases to function and the parcel reverts to R3 status, all R3 zone requirements will be enforced on the parcel.

A motion was made by Commissioner Swartzbacker, seconded by Commissioner Bolt, that the approved PDR allows for the current building height of no more than 34 feet on the existing building. All future building additions must meet the 30 foot maximum building height requirement to be in compliance.
