8 9 10 11 12	AN ORDINANCE OF THE CITY OF LITTLETON, COLORADO, CONCERNING AN AMENDMENT TO A CONSERVATION EASEMENT THAT ENCUMBERS THE PROPERTY AT 2707 WEST MAIN STREET
13 14 15 16	WHEREAS , in 1973, the City of Littleton designated the Carnegie Library building on the property located at 2707 West Main Street as a local historic landmark; and
17 18 19 20	WHEREAS, on January 7, 1983 the property owner and the City of Littleton entered into an agreement titled "Conservation Easement in Gross" recorded January 24, 1983 at reception number 2240833; and
20 21 22 23 24	WHEREAS, the property owner requests approval of a draft amendment, attached to and hereby incorporated as Exhibit A, to the Conservation Easement in Gross to potentially allow new pergola structures as an exception to the easement; and
25 26 27 28	WHEREAS , on April 15, 2019, the City of Littleton historical preservation board held a public meeting to review the proposed amendment to the conservation easement in gross and voted unanimously to deny the amendment; and
29 30 31	WHEREAS , on the 7 th day of May, 2019, the city council held a public hearing on the proposed amendment to the conservation easement in gross; and
31 32 33 34	WHEREAS , the city council considered evidence and testimony concerning the proposed draft amendment to the conservation easement.
35 36 37	NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LITTLETON, COLORADO, THAT:
38 39 40 41	Section 1: The city council finds that the proposed amendment to the conservation easement in gross is consistent with the interests of the City of Littleton and will not have a detrimental impact to the historic character of the Main Street Historic District.
42 43 44 45	Section 2: The city council hereby approves the amendment to the conservation in gross made January 7, 1983 and recorded January 24, 1983, Reception No. 2240833 as shown in Exhibit A.
46 47 48 49	Section 3 : The city council hereby directs the city attorney to make any necessary modifications to the form of the amendment and cause such amendment to be fully executed and recorded as a proper amendment to the original Conservation Easement in Gross.

1 Section 4: Severability. If any part, section, subsection, sentence, clause or 2 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the 3 validity of the remaining sections of this ordinance. The City Council hereby declares that it 4 would have passed this ordinance, including each part, section, subsection, sentence, clause or 5 phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, 6 clauses or phrases may be declared invalid. 7 8 Section 5: Repealer. All ordinances or resolutions, or parts thereof, in conflict 9 with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer clauses of such ordinance nor revive any ordinance thereby. 10 11 12 13 INTRODUCED AS A BILL at a regularly scheduled meeting of the City Council of the City of Littleton on the 16th day of April, 2019, passed on first reading by a vote of 7 FOR 14 15 and 0 AGAINST; and ordered published by posting at Littleton Center, Bemis Library, the 16 Municipal Courthouse and on the City of Littleton Website.
