7 **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF**
8 **LITTLETON, COLORADO, AUTHORIZING A SECOND AMENDMENT**
9 **TO THE INTERGOVERNMENTAL AGREEMENT WITH SOUTH**
10 **SUBURBAN PARK AND RECREATION DISTRICT AND CENTENNIAL**
11 **WATER AND SANITATION DISTRICT FOR MANAGEMENT,**
12 **OPERATIONS, AND MAINTENANCE OF THE SOUTH PLATTE**
13 **RESERVOIR SITE TO ALLOW MEMORIAL BENCHES ALONG THE**
14 **WALKING TRAIL**

16 **WHEREAS**, the council may, by resolution, enter into contracts with other
17 governmental bodies to furnish or receive government services, to make or pay charges for such
18 services, or enter into cooperative or other joint activities with other governmental bodies;

20 **WHEREAS**, the City of Littleton, South Suburban Park and Recreation District,
21 and Centennial Water and Sanitation District entered into an Intergovernmental Agreement
22 (IGA) for Management, Operations, and Maintenance of the South Platte River Site on June 6,
23 2006, as amended by a letter dated September 1, 2011 ("First Amendment"), which provides that
24 no water-based recreation activities are allowed on the South Platte Reservoir; and

26 **WHEREAS**, the IGA and the First Amendment are herein after collectively
27 referred to as the "Intergovernmental Agreement;" and

29 **WHEREAS**, South Suburban Park and Recreation District is now requesting
30 permission to install memorial benches at five locations along the trail on the south side of the
31 South Platte Reservoir walking trail. The locations, bench descriptions, and construction
32 methods are depicted on Exhibit A, attached hereto.

34 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF**
35 **THE CITY OF LITTLETON, COLORADO, THAT:**

37 Authorization of the Second Amendment to the Intergovernmental Agreement
38 with South Suburban Park and Recreation District and Centennial Water and Sanitation District
39 to allow memorial benches along the walking trail of the South Platte Reservoir site is approved.
