ASSIGNMENT

On 05/30/2019 at approximately 1928 hours I, Officer REDMOND was assigned to the Littleton Police Special Enforcement Team (SET Team), was conducting an alcohol compliance check at Santa Fe Spirits at 6023 South Santa Fe Drive.

INVESTIGATION

This compliance check was conducted to audit the sales of alcohol to underage buyers. Abigail BERNSTEIN DOB acted as an underage volunteer for the Littleton Police Department as the individual who purchased the alcohol during this compliance check. At the time of this compliance check Abigail was 16 years 5 months old. ABIGAIL completed a Volunteer Agreement and Liability Waiver which was issued to her by me; this waiver was attached to this report.

Before the check was conducted photos were taken of ABIGAIL photos were also taken after the purchase was complete. These photos were submitted into evidence under this report number. ABIGAIL was issued one twenty dollar bill (S#mf78845272J) which was used for the purchase of the alcohol. ABIGAIL did not possess any other monies on her person.

I entered the establishment in plain clothes after ABIGAIL and I was not identifiable as a Police Officer. I roamed the store while ABIGAIL selected a can of 24 Ounce Bud Lite Strawberita and proceeded to the counter. Once at the counter she encountered the clerk who was later identified as Matthew BRUNKALA DOB.

MATTHEW failed to ask ABIGAIL for her identification and sold her the 24 ounce can of Bud Lite Strawberita. ABIGAIL provided the twenty dollar bill with serial#78845272J to MATTHEW. MATTHEW then gave her the change of \$17.11. ABIGAIL then exited the store with the Bud Lite Strawberita.

Officer BISHARD then contacted MATTHEW advised him that he had sold alcohol to a minor. MATTHEW was issued municipal citation #M1093535 for (6-4-102 Sale or dispensing of alcoholic beverages to any person under 21) with a court date of June 26, 2019.
