9 AN ORDINANCE OF THE CITY OF LITTLETON,
10 COLORADO, AMENDING ORDINANCE NO. 39 SERIES
11 OF 2018 KNOWN AS THE "ANNUAL APPROPRIATION
12 BILL" FOR ALL MUNICIPAL PURPOSES OF THE CITY
13 OF LITTLETON, COUNTIES OF ARAPAHOE, DOUGLAS,
14 AND JEFFERSON, STATE OF COLORADO, FOR THE
15 FISCAL YEAR BEGINNING JANUARY 1, 2019 AND
16 ENDING DECEMBER 31, 2019.

18 WHEREAS, Ordinance No. 39, Series of 2018 established the annual
19 appropriation for municipal purposes for the City of Littleton, Colorado; and

21 WHEREAS, Ordinance No. 2, Series of 2019 amended the annual appropriation
22 for municipal purposes for the City of Littleton, Colorado; and

24 WHEREAS, Ordinance No. 6, Series of 2019 amended the annual appropriation
25 for municipal purposes for the City of Littleton, Colorado; and

27 WHEREAS, appropriations have theretofore been made for the expenditures of
28 monies pursuant to said budget; and

30 WHEREAS, the necessity of receiving and expending additional monies from the
31 various funds could not have been reasonably anticipated during the time of adoption of the
32 budget and appropriation of funds in accordance therewith.

34 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF
35 THE CITY OF LITTLETON, COLORADO, THAT:

37 Section 1: The budget of the City of Littleton for the fiscal year beginning
38 January 1, 2019, and ending December 31, 2019, is hereby amended by additions to the
39 following fund:

42 Section 2: The provisions of the annual appropriations Ordinance No. 39, Series
43 of 2018, are hereby amended with the total of all fund expenditures amended to \$79,334,791.

Section 3: Severability. If any part, section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining sections of this ordinance. The City Council hereby declares that it would have passed this ordinance, including each part, section, subsection, sentence, clause or phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or phrases may be declared invalid.

Section 4: Repealer. All ordinances or resolutions, or parts thereof, in conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer clauses of such ordinance nor revive any ordinance thereby.

INTRODUCED AS A BILL at a regularly scheduled meeting of the City Council of the City of Littleton on the 4th day of June, 2019, passed on first reading by a vote of 6 FOR and 0 AGAINST; and ordered published by posting at Littleton Center, Bemis Library, the Municipal Courthouse and on the City of Littleton Website.

PUBLIC HEARING on the Ordinance to take place on the 2nd day of July, 2019, in the Council Chambers, Littleton Center, 2255 West Berry Avenue, Littleton, Colorado, at the hour of 6:30 p.m., or as soon thereafter as it may be heard.

PASSED on second and final reading, following public hearing, by a vote of FOR and AGAINST on the 2nd day of July, 2019, and ordered published by posting at Littleton Center, Bemis Library, the Municipal Courthouse and on the City of Littleton Website.
