7 **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF**  
8 **LITTLETON, COLORADO, AUTHORIZING THE APPROVAL OF THE**  
9 **2018 ARAPAHOE COUNTY COMMUNITY DEVELOPMENT BLOCK**  
10 **GRANT PROGRAM SUBGRANTEE AGREEMENT FOR THE**  
11 **SHEPPERD AVENUE SIDEWALK IMPROVEMENTS PROJECT**

13 **WHEREAS**, Arapahoe County (the "County") has entered into a grant agreement  
14 (the "Grant Agreement") with the United States Department of Housing and Urban Development  
15 ("HUD") for financial assistance to conduct a Community Development Block Grant Program  
16 (the "CDBG Program") pursuant to Title I of the Housing and Community Development Act of  
17 1974 (the "Act") as amended, and the Rules and Regulations promulgated by HUD governing  
18 the conduct of Community Development Block Grants ("CDBG") programs, 24 Code of Federal  
19 Regulations ("FR") Part 570, as amended, (the "Rules and Regulations"); and

21 **WHEREAS**, the proper application has been made by the City of Littleton to  
22 Arapahoe County for the funding by the Littleton City Council and the Board of County  
23 Commissioners; and

25 **WHEREAS**, in order to receive CDBG funds for the projects, a Subgrantee  
26 Agreement must be adopted by the Littleton City Council and the Board of County  
27 Commissioners.

29 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF**  
30 **THE CITY OF LITTLETON, COLORADO, THAT:**

32 The 2018 Subgrantee Agreement for Arapahoe County Community Development  
33 Block Grant Funds for Project Number LTPF1807 between the City and Arapahoe County for  
34 the Shepperd Avenue Sidewalk Improvements Project is approved.
