## FOURTH AMENDMENT TO FUNDING AGREEMENT FOR RTD FUNDING OF LOCAL TRANSPORTATION SERVICES (CITY OF LITTLETON SHOPPING CART)

This FOURTH AMENDMENT to the Funding Agreement for RTD Funding of Local Transportation Services (City of Littleton Shopping Cart) ("Fourth Amendment") is hereby made by and between the Regional Transportation District ("RTD") and City of Littleton ("LOCAL ENTITY"). RTD and LOCAL ENTITY also may be referred to herein as a "Party" or collectively as the "Parties."

## RECITALS

A. RTD and LOCAL ENTITY entered into an agreement entitled **FUNDING AGREEMENT FOR RTD FUNDING OF LOCAL TRANSPORTATION SERVICES (LITTLETON SHOPPING CART)** dated March 18, 2014 which was amended by the First Amendment to the Agreement dated April 8, 2015, to provide RTD Funding for 2015, the Second Amendment dated February 26, 2016 in order to provide funding for 2016, and the Third Amendment dated May 31, 2017 to provide RTD Funding for 2017 (collectively, the "Agreement");

B. Section 10.H of the Agreement provides that the Parties may amend the Agreement to account for changes in the RTD Funding by a written agreement;

C. In accordance with Section 10.H, RTD and LOCAL ENTITY now desire to amend the Agreement in order to provide the RTD Funding for 2018.

Now, therefore, the Parties agree as follows:

## **AGREEMENT**

- 1. Except as otherwise stated herein, all initially capitalized terms shall have the same meaning as set forth in the Agreement. If there is any conflict between the terms of this Fourth Amendment and the Agreement, the terms of this Fourth Amendment shall control. As modified by this Fourth Amendment, the Agreement shall remain in full force and effect.
- 2. Exhibit B of the Agreement is stricken and replaced with the revised Exhibit B, which is attached hereto and incorporated by reference herein.
- 3. This Fourth Amendment shall become effective upon the last date executed by all Parties.

IN WITNESS WHEREOF, the Parties have duly executed this Fourth Amendment to the Agreement, effective May 15, 2018.
