33 36 37 38 39 40	<u>Section 1</u> . The Intergovernmental Agreement for Coordinated Election between the Arapahoe County Clerk and Recorder and the City of Littleton is hereby approved and the Mayor is hereby authorized to execute such intergovernmental agreement.

The city shall participate in the coordinated election to be held on November 5, 2019, in accordance with the terms and conditions of the intergovernmental agreement, and hereby adopts the exclusive use of the Uniform Election Code of 1992 (Articles 1-13 of Title 1, C.R.S.) with respect to such election.
46	Section 3. The city's designed election official shall be the city clerk, who
