Category NARRATIVE  ASSIGNMENT:  On 07/29/2019 at approximately 2048 hrs I was dispatched to Fraco's Bar located at 5302 S. Federal Cir on report of a physical disturbance between two males.  INVESTIGATION BY OFFICER SNOOK:  Upon arrival I made contact with Steven MOTT, DOB , in the parking out front of the bar. MOTT advised he had been assault by a Hispanic male. MOTT stated he was out front of the bar and the male punched him in the face. MOTT advised he did not know where the male went but the people at the bar knew him as he was a regular customer. MOTT'S only description of the male was he was a Hispanic male approximately 35 years old possibly wearing a white t-shirt  While talking to MOTT I observed his eyes were blood shot and watery. MOTT'S speech was heavily slurred and his balance was unsteady. MOTT advised he had several shots of vodka at home then went to the bar. MOTT advised while he was at Fraco's he had 2 beers and at least 2 vodka sodas. MOTT stated he was at the bar for about and hour and half. MOTT voluntarily completed a PBT and blew a .288.  I observed a red mark on the left side of MOTT'S face and took photographs of him which were forwarded to evidence.  Several other Littleton Police Officer's who were on scene started talking to other patrons at the bar but everyone advised they did not see anything.  I then made contact with Vanessa WILLIS-ZAREMBA, DOB

working at Fraco's at the time the disturbance occurred. WILLIS-ZAREMBA advised she was working behind the bar when her friend Brianna DOKA, DOB came, came in and told her MOTT was outside on the patio calling her a "Dike" and other derogatory names. WILLIS-ZAREMBA said DOKA stated MOTT was also calling other patrons names as well causing a disturbance. WILLIS-ZAREMBA stated she went outside and took a beer away from MOTT, told him he needed to pay his bill, and leave. WILLIS-ZAREMBA stated MOTT came inside paid his bill and left out the front door. WILLIS-ZAREMBA stated a few moments later she heard people yelling that there was a fight out front. WILLIS-ZAREMBA stated she went out front and MOTT was yelling he was going to call the police. WILLIS-ZAREMBA stated she heard MOTT had been in a fight with a customer named "Arthur" who goes by the moniker "Turtle". WILLIS-ZAREMBA advised she did not know where "Arthur" went but he was no longer on scene

WILLIS-ZAREMBA provided me the bill for MOTT which had a time of 1821 hrs on it. The bill was for 3 vodka drinks and 3 beers. WILLIS-ZAREMBA advised "Arthur" left without paying his bill but it was for 4 Jack Daniels drinks and 2 beers. The receipts were booked into evidence.

WILLIS completed written statement

I then spoke to DOKA who advised she is a part time bartender at Fraco's but was not working tonight. DOKA advised she was outside on the patio and MOTT started calling her a "Dike bitchy bitch" and other derogatory names. DOKA stated MOTT was calling other customer's names and threatening them. DOKA advised she went and told WILLIS-ZAREMBA what was going and WILLIS-ZAREMBA had him leave. DOKA advised MOTT then left the bar but stood out front in the parking lot yelling at the people outside on the patio stating he would be back for them. WILLIS-ZAREMBA stated she then heard yelling, a commotion on the patio, and then heard MOTT state he was calling the police. WILLIS-ZAREMBA advised she did not know "Arthur" hit MOTT.

DOKA advised when she arrived at the bar around 1900 hrs she observed MOTT appeared heavily intoxicated as he speech was heavily slurred.

DOKA completed a written statement

I then spoke to Yelena BYERS, DOB was not at the bar during the disturbance. BYERS advised he bar does have surveillance cameras but none outside the bar.

I reviewed the surveillance video with BYERS and DOKA and saw one of the surveillance camera angles you can see a small portion of the outside patio from inside the bar. The video shows DOKA come into the bar and get WILLIS-ZAREMBA. WILLIS-ZAREMBA then goes outside and returns with MOTT. MOTT is then seen leaving out the front door of the bar. The surveillance video then shows a male, who DOKA and WILLIS-ZAREMBA advise is "Arthur", throwing a punching. The video then shows DOKA go out front and separate him from an unknown person. "Arthur" then goes back inside the bar.

I recorded a copy of the surveillance video and booked it into evidence.

I then issued WILLIS-ZAREMBA citation #E0059248 for sale of alcohol to an intoxicated person.

I issued MOTT citation #E0059247 for disorderly conduct and he was released to his mother due to his level of
