Assignment:

On 07/26/2019 at approximately 2025 hours, Officer Redmond and I were conducting Alcohol Compliance Checks, as members of the LPD SET Team. These compliance checks were conducted in order to audit the sales of alcohol to underage buyers. Officer Redmond and I were dressed in plain clothes, and were not identifiable as Police Officers. We were accompanied by Abigail [REDACTED] who was our designated volunteer to conduct the Alcohol Compliance Checks. At the time of this compliance check [REDACTED] was 16 years and 7 months old. [REDACTED] age was verified by her parent. A criminal history check was completed on [REDACTED] and it was determined that she did not have a criminal record or any pending criminal charges. [REDACTED] previously completed a Volunteer Agreement and Liability Waiver which was issued to her by me; this waiver is currently on file with the LPD SET team.

Officer Redmond and I conducted multiple randomized compliance checks at various restaurants throughout the City of Littleton.

Investigation by Officer A.Larson 201509:

At approximately 2025 hours, [REDACTED], Officer Redmond and I, entered India's Best located at 1500 W Littleton Blvd. I observed approximately seven other customer's inside of the establishment. The waiter, later identified by Colorado Driver's License as Omar ALRADDADI (DOB [REDACTED]), approached us while we were seated at the bar and asked us what we would like to drink. Officer Redmond and I advised that we did not want anything to drink. [REDACTED] told ALRADDADI she would like a "Blue Moon", which was a beer located on the beverage menu. ALRADDADI failed to ask [REDACTED] for her ID or her age during their interaction. Shortly later, ALRADDADI returned and placed a mug containing approximately 12 ounces of Blue Moon in front of [REDACTED]. I took photos of the [REDACTED] holding the beer ALRADDADI served to her. Photos were taken of [REDACTED] prior to the compliance check being conducted; these photos were submitted into LPD evidence under this report number. At this time, [REDACTED] exited the restaurant, and Officer Redmond and I informed ALRADDADI that we were Littleton Police Officer's and that he had failed an alcohol compliance check. ALRADDADI walked outside with us and we met Sergeant Kampmann, who was dress in a Littleton Police class B uniform. Sergeant Kampmann completed a municipal citation that I served to ALRADDADI for Sale of Dispensing of Alcoholic Beverages to Person Under 21 (M1094651) with a court date of 08/21/2019 at 0930 hours.

ALRADDADI was polite and cooperative throughout our interaction and apologized for serving the alcohol to [REDACTED] without verifying her age.

Prior to entering the establishment, I was issued two ten dollar bills (SN# ML57139580A, SN# JL21923610B) which were used for the purchase of the alcohol. The bills were photographed and submitted into evidence under this report. I paid for the beer [REDACTED] ordered with one of the ten dollar bills provided by the department and received \$4.64 dollars in change.

I have attached the municipal summons, receipt for the purchase, and [REDACTED] written statement to this report. Nothing further at this time.
