27	NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF
28	THE CITY OF LITTLETON, COLORADO, THAT:

30	Section 1: Littleton City Code Title 10, Chapter 1 is hereby amended in
31 32	accordance with Exhibit A.
52 33	Section 2: Severability. If any part, section, subsection, sentence, clause or
33 34	phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the
35	validity of the remaining sections of this ordinance. The City Council hereby declares that it
36	would have passed this ordinance, including each part, section, subsection, sentence, clause or
37	phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences,
38	clauses or phrases may be declared invalid.

40	Section 3: Repealer. All ordinances or resolutions, or parts thereof, in
41	conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the
42 43	repealer clauses of such ordinance nor revive any ordinance thereby.
