Category **NARRATIVE**

Assignment:

On 05/31/2019 at approximately 1550 hours, Officer Bishard and I were conducting Alcohol Compliance Checks, as members of the LPD SET Team. These compliance checks were conducted in order to audit the sales of alcohol to underage buyers. Officer Bishard and I were dressed in plain clothes, and were not identifiable as Police Officers. We were accompanied by Abigail E. [REDACTED] who was our designated volunteer to conduct the Alcohol Compliance Checks. At the time of this compliance check [REDACTED] was 16 years and 5 months old. [REDACTED] age was verified by her parent. A criminal history check was completed on [REDACTED] and it was determined that she did not have a criminal record or any pending criminal charges. [REDACTED] completed a Volunteer Agreement and Liability Waiver which was issued to her by me; this waiver was attached to this report. Officer Bishard and I conducted multiple randomized compliance checks at various restaurants throughout the City of Littleton.

Investigation by Officer A.Larson 201509:

At approximately 1550 hours, [REDACTED], Officer Bishard and I, entered Walter's 303 Pizzeria located at 5194 S Lowell Blvd. I observed approximately two other customer's inside of the establishment. The waitress, later identified by Colorado Driver's License as Takyra LEBLANIC [REDACTED] approached us while we were seated at a booth and asked us what we would like to drink. Officer Bishard and I advised that we needed additional time to decide. [REDACTED] told LEBLANIC she would like a "Station 26 303 Lager", which was a beer located on the beverage menu. LEBLANIC asked [REDACTED] to see her ID and which time [REDACTED] advised that she did not have it in her possession. LEBLANIC responded by stating, "Ok, I trust you" then left the table to retrieve the alcoholic beverage [REDACTED] requested. LEBLANIC failed to asked [REDACTED] her age during their interaction. Shortly later, LEBLANIC placed an open 12 ounce can of Station 26 303 Lager and placed it in front of [REDACTED]. Officer Bishard took several photos of the beer, and a label located on the can showing that it contained 5% alcohol by volume. Officer Bishard also took a photo of [REDACTED] holding the beer LEBLANIC served to her. Photos were taken of [REDACTED] prior to any compliance check being conducted; these photos were submitted into LPD evidence under this report number.

At this time, [REDACTED] exited the restaurant, and Officer Bishard and I informed LEBLANIC that we were Littleton Police Officer's and that she had failed an alcohol compliance check. LEBLANIC walked outside with us and we met Officer Redmond, who was dress in a Littleton Police class B uniform. Officer Redmond completed a municipal citation that I served to LEBLANIC for Sale of Dispensing of Alcoholic Beverages to Person Under 21 (M1093536) with a court date of 06/26/2019 at 0930 hours.

LEBLANIC was polite and cooperative throughout our interaction and apologized for serving the alcohol to [REDACTED] without verifying her age.

Prior to entering the establishment, [REDACTED] was issued one twenty dollar bill (SN# MF78845272J) which was used for the purchase of the alcohol. The bill was photographed and submitted into evidence under this report. Officer
