| ASSIGNMENT On 05/31/2019 at approximately 1858 hours I, Officer Bishard who assigned to the Littleton Police Special Enforcement Team (SET Team), was conducting an alcohol compliance check at Wang's Gourmet located at 12 E. Arapahoe Road. This compliance check was conducted to audit the sale of alcohol to underage buyers. ABIGAIL acted as an underage volunteer for the Littleton Police Department as the individual who purchased the alcohol during this compliance check. At the time of this compliance check ABIGAIL was 16 years and 5 months old which was confirmed by her mother Brandi Urenda due to ABIGAIL not having any form of identification. A criminal history check was done on ABIGAIL and it was determined that she did not have a criminal record or any pending criminal charges. ABIGAIL completed a Volunteer Agreement and Liability Waiver which was issued to her by me; this waiver provided to Sergeant Kampmann along with her criminal history check. INVESTIGATION Before the check was conducted, photos were taken of ABIGAIL. These photos documented what ABIGAIL looked like at the time of the alcohol purchase. These photos were submitted into evidence under this report number. I entered the establishment with Officer Larson and ABIGAIL and was sat at a table in the main room of the restaurant. Upon being seated we were greeted by our server who was later identified as LIN, YUCHAN (DOB) via a Colorado ID. YUCHAN asked our table what we wanted to drink before taking our food order. Both Officer Larson and I asked for water and ABIGAIL ordered a Bud Light. YUCHAN did not ask ABIGAIL for an ID and did not ask her how old she was. YUCHAN left the table briefly and returned with an opened 12oz glass bottle of Bud Light. Upon inspection of the bottle it was ice cold and read Bud Light on the side. The label also identified that it was 4.2% alcohol by volume. Photos of ABIGAIL at our table holding the bottle of beer were taken and submitted into evidence. While the citation was completed by Officer Redmond who was in his patrol uniform, YUCHAN voluntarily stated, "I am sorry. I got busy and was just so nervous". YUCHAN was issued a municipal citation for 6-4-102 (Sale or Dispensing of Alcoholic Beverages to Any Person Under Twenty One) by me.

While at the business I paid the cashier \$3.21 which was the total cost of the \$2.99 beer plus tax. I was supplied with a receipt which was copied; the copy of the receipt was attached to this report. ABIGAIL completed a written statement regarding this purchase that was also attached to this report.
