SUPPLEMENTAL REPORT by OFFICER OREN On March 7, 2019 at approximately 2118 hours, I assisted Officer Ray and his investigation at The Boardroom which is located at 51 West Dry Creek Court, City of Littleton, County of Arapahoe, and State of Colorado. During the investigation, I issued a citation (M1093643) to Jason GALLEGOS for Sale to Intoxicated Persons (3-2-10(f)). I positively identified GALLEGOS by his CO DMV Dossier During Officer Ray's investigation, he arrested Andrew LUCE for Menacing (6-4-25) and Disorderly Conduct (6-4-72(a)). LUCE was heavily intoxicated. LUCE urinated on himself and was noncompliant with our commands. Alex WOODS who is the owner of The Boardroom explained that at approximately 1730 hours, his employees notified him that they were uncomfortable serving LUCE any alcohol. WOODS provided me LUCE's receipt which was time stamped at 4:42 PM. The items on the receipt were a 16 ounce Dales Pale and two shots of Jack Daniels Whiskey. GALLEGOS was the bartender that served LUCE at that time. WOODS said that there was one empty bottle of vodka that they don't sell under the table of where LUCE was located. WOODS did show me an empty 50ml bottle of vodka. It is unknown whether or not that bottle was there before LUCE arrived. Due to LUCE's level of intoxication (See Officer Ray's report for further information), I issued GALLEGOS a citation. Officer Oren #1803, 03/08/2019							
Category NARRATIVE ASSIGNMENT: On 03/07/2019 at approximately 2114 hours, I was dispatched to the Boardroom, located at 51 West Dry Creek Court, City of Littleton, County of Arapahoe, State of Colorado, in regards to a disturbance. INVESTIGATION: When I arrived on Scene, I contacted the manager of the Boardroom, Alex Paul Woods who told me that Andrew Robert Luce was in a confrontation with patrons and pulled a knife on them. Woods stated that Luce put the knife away when asked to do so by him. Woods described the knife as a folding knife approximately four to five inches long. When Woods asked Andrew to leave the building he argued with him and other customers yelling obscenities and trying to start a fight. Woods added when he was able to get Luce out of the building when Luce reached in the pocket he had previously placed the knife. Woods took Luce down to the ground,

I advised Luce that he was under arrest for menacing and disorderly conduct. I then placed Luce in the back of my patrol car, which was checked for contraband prior to and after the arrest with no contraband found. I transported Luce back to LPD to complete probable cause paperwork. While in rout to the LPD headquarters Luce spontaneously uttered "I only had four beers and three shots of whisky" at the boardroom.

had urinated himself prior to my arrival. Luce's pants were wet and there was a puddle of urine on the ground under

Luce was uncooperative and belligerent while at LPD headquarters and during transport to Arapahoe County Jail. Luce refused to perform a personal breath test at both locations. Luce constantly pounded on the walls of the holding cell at LPD headquarters and insulted multiple LPD Officers that had to continuously check on him because of his combative behavior. Luce repeatedly demanded to receive a phone call and stated he wanted to talk to his layer because he was being "Illegally held in jail." Luce called Officers "Fucking Assholes" and flipped them off telling them to "Go fuck yourself."

I transported Luce to Littleton hospital and he was medically cleared by Dr. Casey Dixon Dart. After being medically cleared by hospital staff I transported Luce to Arapahoe County Jail where he was booked in on a \$1000 bound and given a citation (M1093567) for Menacing (6-4-25) and Disorderly Conduct 6-4-72(A).

The Boardroom provided a copy of a bar tab which belonged to Luce in the amount of \$18.75 which showed the order of one Dales Pale Ale and two Jack Daniels. I observed the bar tab to have guest time of approximately 1642 hours on 03/07/2019. Officer Oren issued the Boardroom waiter Jason Christopher Gallegos (M1093643) for serving an intoxicated person (3-2-10(F).

I confiscated the knife found on Andrew. The knife was manufactured by SPYDERCO and had a curved blade approximately 3.75 inches long with a brass and black plastic handle. I later booked the knife and into LPD evidence.
