20	(collectively the "Parties") desire to fund a Census Coordinator Position ("Position") with
21	Arapahoe County, which person shall serve as the primary contact and coordinator for al
22	those within Arapahoe County to ensure accuracy of the U.S. Census Bureau count within
23	the county; and

25	WHEREAS, the Parties intend to fund the Position; and

27	WHEREAS, the total salary of the Position is estimated to be eighty
28	thousand dollars (\$80,000) with Littleton's prorated share not to exceed five thousand
29	dollars (\$5,000).
