## CITY OF LITTLETON, COLORADO **Resolution No. 1 Series**, 2021 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LITTLETON, COLORADO, SPECIFYING THE LOCATION WHERE NOTICES OF PUBLIC MEETINGS ARE TO BE POSTED AND IDENTIFYING THE NEWSPAPER WHERE NOTICES AND OTHER

**WHEREAS**, pursuant to the Colorado Open Meetings Law, §§ 24-6-401, *et seq.*, C.R.S., as amended, the City of Littleton, as a local public body, is required to give timely and adequate notice of its meetings;

INFORMATION REQUIRED TO BE PUBLISHED WILL BE PRINTED

**WHEREAS**, pursuant to § 24-6-402(2)(c) C.R.S., as amended, "...a local public body shall be deemed to have given full and timely notice if the notice of the meeting is posted in a designated public place within the boundaries of the local public body no less than twenty-four hours prior to the holding of the meeting. The public place or places for posting such notice shall be designated annually at the public body's first regular meeting of each calendar year"; and

WHEREAS, pursuant to section 1-3-2 of the Littleton City Code, "For the purposes of the charter and the municipal code, except where publication in a newspaper is specifically required by the charter, an ordinance or state statute, the terms "publication", "publish" or "published" shall mean a minimum of two (2) of the following three (3) methods: a) posting on the city's website; b) physical posting at the Littleton Center, Bemis public library and the Littleton municipal courthouse; or c) publication in a newspaper of general circulation in the city";

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LITTLETON, COLORADO, THAT:

 **Section 1.** The city council hereby designates the City of Littleton website, <a href="https://www.littletongov.org">www.littletongov.org</a>; and the bulletin boards at the main entrances of the Littleton Center, 2255 West Berry Avenue; Bemis Library, 6014 South Datura Street; and the Littleton Municipal Courthouse, 2069 West Littleton Boulevard, as the locations where all notices required to be posted concerning open meetings shall be posted.

**Section 2**. Notices and other information, when specifically required by the charter, an ordinance or state statute to be published in a newspaper of general circulation within the City of Littleton, shall be published in the *Littleton Independent*.
