Arapahoe County has been doing polling regarding the Arapahoe County Open Space Fund. The current tax is due to sunset in 2023 so the county has been exploring, much like the city is doing, possible sales tax measures. So far, results of their polling have been pretty favorable; 78% of Arapahoe County voters would vote "yes" on this measure. We may see this on the ballot in the fall. / Update on NextGen and the Denver Metroplex: Refresher that in 2007, the FAA began working on a program called NextGen to modernize the nation's air transportation system at 35 of the busiest regional air regions within the U.S. DIA is the 5th busiest in the U.S. and the Denver Metroplex, which includes the Rocky Mountain Metropolitan Airport, Centennial Airport, and other regional airports, is one of the busiest in the nation. Centennial Airport is the second busiest non-commercial airport. The purpose of NextGen was to increase safety, efficiency, reliability, predictability, and capacity which has to do with relying more on satellite technology vs ground-to-air for air traffic control. Part of the proposed updates included changing some of the air-traffic routes which resulted in approximately 29 different routes in to and out of DIA being proposed to change. In 2019, the FAA entertained a public comment period, which the City of Littleton responded to and we expressed our concerns that we did not feel they had done enough to address the Environmental Protection Act, in particular the impact these changes would have on noise, our citizens, and other areas. The patterns were instituted in March of 2020. In March of 2020, due to COVID, all meaningful air travel was grounded so the impacts of these changed routes were not immediately observed due to the limited number of flights operating. Because more people were working from home, it was noticed when a plane flew closely overhead.

As a result, the city received a large number of noise complaints which were forwarded to DIA. Littleton has primary concern with two of the new routes; the Bronco route and the Pinner route. Both of these routes force air traffic from the north to fly more to the west than has happened prior to these changes. These changes for flights coming in to DIA have forced Centennial Airport to move more of their non-commercial flights to areas further south and west. Last year, Centennial Airport and the counties of Arapahoe, Douglas, and Gilpin, as well as the City of Greenwood Village, filed a lawsuit asking for a review in federal court of the FAA's finding of "not a significant impact". The lawsuit was recently dismissed by the federal court on the basis that all of these organizations (the counties, the airport, and Greenwood Village) didn't have standing to sue based on no claim of injury to each/any of these organizations.

c) Council Members

Council Member Grove - Thank you to everyone who attended the Meet, Greet and Eat at Sterne Park on June 30. We had a great turnout! We had the opportunity to talk to citizens one-on-one and discussed many issues. These issues are now being researched by staff. The next Meet, Greet and Eat will be July 14 at Progress Park from 4:00 to 6:00 p.m.

Council Member Rudnicki - Commend the city on doing a great job with the Meet, Greet and Eat. Talked to many citizens about various issues including the ULUC. Great crowd!

Council Member Driscoll - Attended the ACC (Arapahoe Community College) EMS Academy on June 16 as part of the advisory board representing the city. Anyone looking to become a paramedic or EMT, highly recommend the ACC program.

Council Member Fey - The High Line Canal Conservancy recently reported that they considered over 100 projects for the length of the 71 miles; 10 projects were chosen to be funded. One of those is in Littleton!

Mayor Pro Tem Melin - Reminder that the comment period on the draft ULUC closes on July 30. If you haven't already, please get your comments in; we want to hear them.
