8 AN ORDINANCE OF THE CITY OF LITTLETON,
9 COLORADO, AMENDING ORDINANCE NO. 36 SERIES OF
10 2020 KNOWN AS THE “ANNUAL APPROPRIATION BILL”
11 FOR ALL MUNICIPAL PURPOSES OF THE CITY OF
12 LITTLETON, COUNTIES OF ARAPAHOE, JEFFERSON
13 AND DOUGLAS, STATE OF COLORADO, FOR THE
14 FISCAL YEAR BEGINNING JANUARY 1, 2021 AND
15 ENDING DECEMBER 31, 2021

17 WHEREAS, Ordinance No. 36, Series of 2020 established the annual
18 appropriation for municipal purposes for the City of Littleton, Colorado; and

19
20 WHEREAS, appropriations have theretofore been made for the expenditures of
21 monies pursuant to said budget; and

23 WHEREAS, the necessity of receiving and expending additional monies from the
24 various funds could not have been reasonably anticipated during the time of adoption of the budget
25 and appropriation of funds in accordance therewith.

27 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF
28 THE CITY OF LITTLETON, COLORADO, THAT:

30 Section 1: The budget of the City of Littleton for the fiscal year beginning
31 January 1, 2021, and ending December 31, 2021, is hereby amended by additions to the following
32 fund:

38 Section 2: The provisions of the annual appropriations Ordinance No. 36,
39 Series of 2020, are hereby amended with the total of all fund expenditures amended to
40 \$78,875,829.

42 Section 3: Severability. If any part, section, subsection, sentence, clause or
43 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the
44 validity of the remaining sections of this ordinance. The City Council hereby declares that it would
45 have passed this ordinance, including each part, section, subsection, sentence, clause or phrase
46 hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or
47 phrases may be declared invalid.

49 Section 4: Repealer. All ordinances or resolutions, or parts thereof, in conflict

50 with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer
51 clauses of such ordinance nor revive any ordinance thereby.

54 INTRODUCED AS A BILL at a regularly scheduled meeting of the City Council
55 of the City of Littleton on the 20th day of July, 2021, passed on first reading by a vote of 7 FOR
56 and 0 AGAINST; and ordered published by posting at Littleton Center, Bemis Library, the
57 Municipal Courthouse and on the City of Littleton Website.

58 PUBLIC HEARING on the Ordinance to take place on the 3rd day of August, 2021,
59 in the Council Chamber, Littleton Center, 2255 West Berry Avenue, Littleton, Colorado, at the
60 hour of 6:30 p.m., or as soon thereafter as it may be heard.
