a) City Manager

Changed the tentative calendar to move the 2nd reading Public Hearing on Aspen Grove from October 5 to the special meeting October 12. Updated information about the officer involved shooting that took place this morning. One officer is in intensive care with multiple gunshot wounds and another officer, who was not shot, was wounded as part of the incident.

Council Member Milliman - Positive energy to the Littleton Police Department. She went to the fine arts board meeting and informed that November 11 will be the Own an Original and the Secret Life of Clothes reception. At the community art project called One Book at Bemis Library there were thirty-one people attended a two day workshop. South Metro Housing Options met this month regarding a foster youth program to keep foster youth from becoming homeless. South Metro Housing Options has a new Resident Services Director, Joanna Crosby and a new Director of Housing, Helen Hoy. The Housing Task Force met this month and are disappointed with the ULUC and ADU's and parking and these items may be going in a good direction. Kathleen Osher and Corey Reitz will be attending a session of the inclusionary zoning cohort with DRCOG and should learn a lot.

Council Member Fey - Encouraged everyone interested in the Littleton Immigration Resource Center to stay until General Business where council will discuss the Tri City Homelessness Action Plan which could be connected to both. Littleton has not been asked to contribute any money to the Homelessness Policy Group effort. With Littleton pulling back from the immigration may allow other jurisdictions to step up

with assistance. She is committed to helping a regional immigration resource center. She also offered well wishes to the injured officers.

Council Member Driscoll - Thanked Frank Atwood for the memorial tree dedication to Jerry Hill. He attended the Masons for their 100 Cornerstone Celebration on Saturday.

Council Member Rudnicki -Ditto the comments of others regarding the officer. We have a responsibility to care about the citizens and workers and his heartfelt wishes that the officer recovers quickly. He is the liaison for the Arts and Culture Commission and he attended the Fine Arts Board on September 9. He learned a lot, discussed the impact of art on a community and the importance of building and art together, and how art creates something to draw visitors.

d) Mayor

Discussed calls he gets from citizens regarding others blowing through stop signs around schools. He suggested the schools send letters to parents with regard to safety and stop signs. Council discussed the budget on a Saturday and got the budget completed. Leaders have to made tough decisions regarding cuts. LIRC was voted to be defunded in 2018 and this current council has decided to defund as well. It was expected that LIRC would get donations to fund the program and that didn't come to fruition. Praised the Littleton Police Department and what they do and how much he appreciates them. He received much support from other cities regarding the shooting and he sends thoughts and prayers to the family. He took food to the station and to the investigation sight to support the police department.
